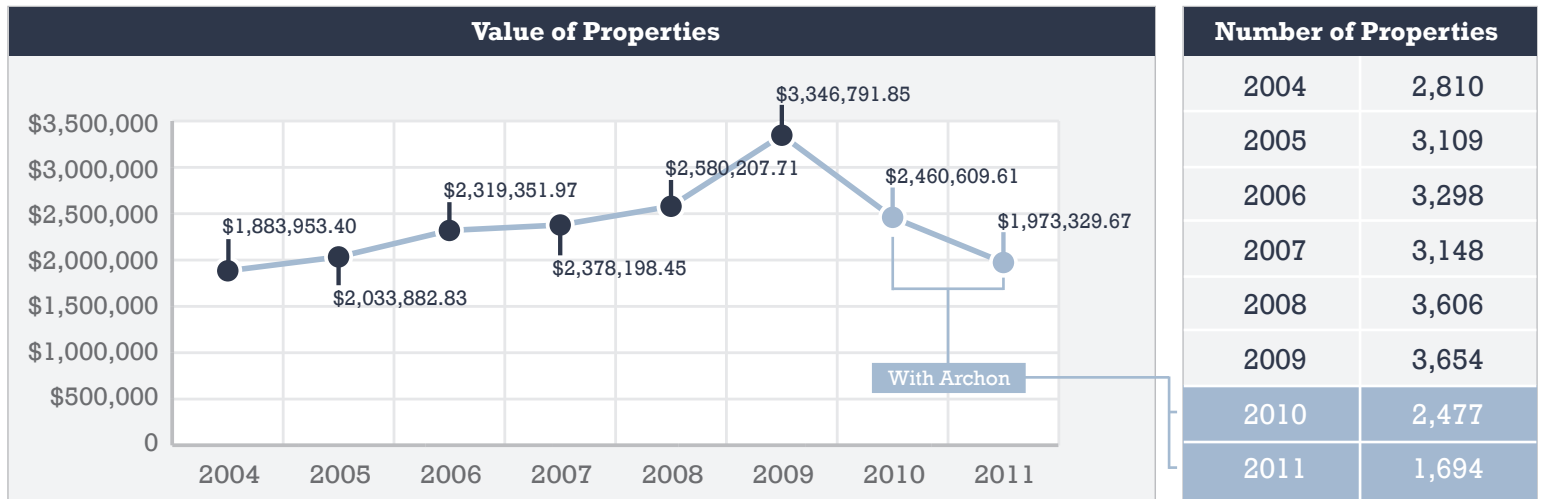

Caddo Parish Sheriff Tax Collection Results

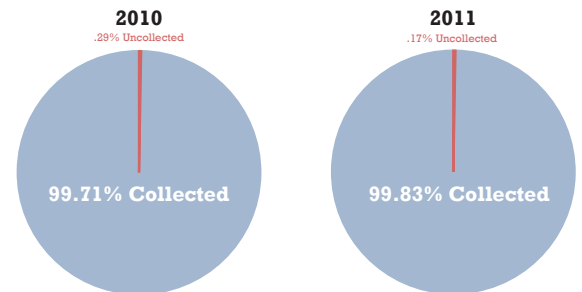
Properties Taken to Sale By Year
